Executive Summary

ES.1 Background Information on National Greenhouse Gas Inventory

The guidelines in Article 4 and Article 12 of the United Nations Framework Convention on Climate Change (UNFCCC) and Article 5 of the Kyoto Protocol state that each party shall submit information on its progress in response to climate change to the UNFCCC Convention of the Parties for review. In particular, the National Inventory Report (NIR) is a national report in which the UNFCCC¹ requires each Annex 1 country to report on its national greenhouse gas (GHG) inventory describing the procedures for GHG emission inventory preparation, information on emission trends, statistics by sectors, and a national report of re-calculation while submitting its inventory based on Common Reporting Format (CRF). Although Taiwan is not a UNFCCC party, it has long been committed to fulfilling its responsibility as a member of the global community by endeavoring to take initiatives to help slow down global warming. The establishment of a national GHG inventory report and the estimation of GHG emission and sequestration are the fundamental obligation of a country to UNFCCC as well as one of the essential steps in reducing global warming.

Since 1998, Taiwan has taken initiatives to prepare the national GHG inventory. According to Decision 24/CP.17 of the 17th Convention of the Parties (COP17) of the United Nations Framework Convention on Climate Change and the 7th Session of the Conference of the Parties (CMP7) to the Kyoto Protocol held in Durban, requesting developed countries to submit an Annual National Inventory Report starting from 2015 in accordance with the 2006 Intergovernmental Panel on Climate Change Guidelines (2006 IPCC Guidelines) for National Greenhouse Gas Inventories proposed by the Intergovernmental Panel on Climate Change (IPCC) in 2006. The Report also carried out the statistics and compilation in accordance with the 2006 IPCC Guidelines to actively demonstrate the efforts and resolution to abide by the convention. Today, Taiwan has established a greenhouse gas inventory database covering the period from 1990 to 2019. The database provides an overview on greenhouse gas inventory statistics to reflect the GHG trends in Taiwan. It also aims to quantify future greenhouse gas emissions and provide an overview of Taiwan's greenhouse gas statistics, thereby receiving comments from all fields for the continuous improvement on the quality of national greenhouse gas inventories.

ES.2 Summary of National Emission and Absorption Related Trends

Taiwan's total GHG emissions increased from 137,776 kilotons of carbon dioxide equivalents (excluding land use, land use change and forestry, the following report abbreviated as LULUCF) in 1990 to 287,060 kilotons of carbon dioxide equivalents (excluding LULUCF) in 2019, with emissions increased by 108.35% at an average annual growth rate of 2.56%. Among the greenhouse gas emissions in 2019, the proportion of carbon dioxide emissions is 95.28% and that of non-carbon dioxide is 4.72%. Compared with 2005(Base year) GHG emissions, it decreased slightly by 1.20%. The total emissions in 2019 saw a decrease of 3.41% from the previous year, as shown in Figure ES2.1.

Further comparison of statistics on various greenhouse gas emissions shows that carbon dioxide accounts for the majority of greenhouse gas emissions (excluding LULUCF) in Taiwan in 2005, accounting for 91.71%, followed by methane (3.27%), nitrous oxide (1.48%), and fluorinated greenhouse gas (3.54%) ; however, carbon dioxide was still the largest of proportion (95.28%) in 2019, followed by nitrous oxide (1.71%), methane (1.67%), and then fluorinated greenhouse gas (1.34%), as shown in Figure ES2.2.

Between 1990 and 2019, carbon dioxide emissions grew by 120.44% with an average annual growth rate of 2.76%; carbon dioxide sequestration decreased by 8.32% with an average annual growth rate of -0.30%; methane emissions decreased by 55.29% with an average annual growth rate of -2.74%, a negative growth; nitrous oxide emissions increased by 63.91% with an annual growth rate of 1.72%. Between 1993 and 2019, fluorinated greenhouse gas emissions grew by 410.63% with an average annual growth rate of 6.47%, as shown in Figure ES2.3 and Table ES2.1.



1. Carbon Dioxide

The energy sector, industrial process and product use (IPPU)sector, agriculture sector, and waste sector are the main emission sources of carbon dioxide in Taiwan, as shown in Table ES2.2. In 1990, Taiwan's carbon dioxide emissions amounted to 124,078 kilotons of carbon dioxide equivalents. In 2019, that figure was 273,515 kilotons of carbon dioxide equivalents, with an 120.44% increase and an average annual growth rate of 2.76%. In 2019, carbon dioxide emissions

accounted for 95.28% of total GHG emissions. The energy sector accounted for 94.59%, the industrial process and product use (IPPU)sector 5.32%, the waste sector 0.08%, and the agriculture sector 0.01%. Emissions in 2019 increased by 2.65% compared to 2005(Base year). Compared with 2018, the emissions in 2019 decreased by 3.30% mainly because of the 3.15% decrease in the energy sector, the 6.26% decrease in the IPPU sector, the 1.50% decrease in the agriculture sector, and the 34.40% increase in the waste sector.



(a) Emissions exclude LULUCF ; (b) Emissions include LULUCF






Figure ES2.3 1990-2019 Trends in Total Greenhouse Gas Emissions and Sequestration by Type in Taiwan

2. Methane Emissions

Methane emissions in Taiwan mainly come from the agriculture sector, waste sector, and energy sector, as shown in Table ES2.3. In 1990, the total methane emission in Taiwan was 10,705 kilotons of carbon dioxide equivalents. In 2019, the total methane emission was 4,786 kilotons of carbon dioxide

equivalents, down by 55.29% with an average growth rate of -2.74%, a negative growth. In 2019, methane emissions accounted for 1.67% of the total GHG emissions. In particular, the waste sector was the largest source of methane emissions in 2019, which accounted for 43.91%, followed by the agriculture sector (40.57%), energy sector (14.98%), and IPPU sector (0.54%).

National Greenhouse Gas Inventory

Emissions of Methane in 2019 decreased by 49.66% compared to 2005(Base year). Compared to 2018, the methane emission in 2018 was down by 2.15%, with the waste sector down by 4.94%, the IPPU sector down by 3.32%, the energy sector down by 0.57%, and the agriculture sector up by 0.48%.

3. Nitrous oxide emissions

Nitrous oxide emissions in Taiwan are mainly from the IPPU sector, the agriculture sector, and energy sector with minor emissions from the waste sector, as shown in Table ES2.4. In 1990, the total nitrous oxide emission in Taiwan was 2,992 kilotons of carbon dioxide equivalents. In 2019, the total nitrous oxide emission was 4,904 kilotons of carbon dioxide equivalents, up by 63.91% with an average growth

rate of 1.72%. In 2019, nitrous oxide emissions accounted for 1.71% of the total GHG emissions. In particular, the IPPU sector accounted for 39.98%, followed by the agriculture sector (27.12%), the energy sector (25.00%), and the waste sector (7.90%).

Emissions of Nitrous oxide in 2019 increased by 14.04% compared to 2005(Base year). Compared to 2018, the nitrous oxide emission in 2019 was down by 3.69%, with the IPPU sector down by 5.15%, the agriculture sector down by 3.97%, the energy sector down by 2.44%, and the waste sector up by 1.08%.

4. Fluoride-Containing Gas Emissions

In Taiwan, the majority of fluorinated greenhouse gases come from industries critical to economic development, namely the semiconductor, optoelectronics, power facilities, and magnesium alloy industries, all of which are emission-heavy industries. The fluorinated greenhouse gas emissions are shown in Table ES2.5. In particular, Taiwan's hydrofluorocarbons (HFCs) emission increased from 755 kilotons of carbon dioxide equivalents in 1993 to 1,027 kilotons of carbon dioxide equivalents in 2019. The perfluorocarbons (PFCs) emission increased from 3 kilotons of carbon dioxide equivalents in 1999 to 1,420 kilotons of carbon dioxide equivalents in 2019, while the sulfur hexafluoride (SF₆) emission increased from 116 kilotons of carbon dioxide equivalents in 1999 to 935 kilotons of carbon dioxide equivalents in 2019. The nitrogen trifluoride (NF₃) emission increased from 11 kilotons of carbon dioxide equivalents in 1999 to 473 kilotons of carbon dioxide equivalents in 2019. For the total emission of fluorinated greenhouse gases, it increased from 1,738 kilotons of carbon dioxide equivalents in 1999 (about 0.77% of the total greenhouse gas emissions in 1999) to 3,855 kilotons of carbon dioxide equivalents in 2019 (about 1.34% of the total greenhouse gas emissions in 2019), with an emissions increase of 121.79% at an average annual growth rate of 4.06%. Emissions of fluoride-containing gas in 2019 decreased by 62.51% compared to 2005(Base year). Compared to 2018, the emission in 2019 decreased by 11.58%.

ES.3 Emission Estimation and Trends Overview for Emission Source and Sinks Classification

Of all the sectors, the energy sector has long been the one accounting for the largest total greenhouse gas emission in Taiwan over the years. In 2005 and 2019, greenhouse gas emissions (exclude LULUCF) from energy sectors were responsible for approximately 85.99% and 90.80% of the total emissions, while the IPPU sector accounted for 10.12% and 7.10%, the agricultural sector accounted for 1.37% and 1.15%, and the waste sector accounted for 2.52 % and 0.94%, as shown in Figure ES3.1.

The GHG emission and trends for Taiwan from 1990 to 2019 by sector are shown in Figure ES3.2 and Table ES3.1. The total greenhouse gas emission in Taiwan in 2019 decreased by 3.41% compared with 2018. In particular, the GHG emission from the energy sector was down by 3.14%, the IPPU sector was down by 7.21%, the agriculture sector was down by 1.38%, and the waste sector was down by 1.83%. Additionally, the carbon dioxide sequestration of the land use, land use change and forestry sector was down by 0.31%.

Compared to 2005(Base year), the emission in 2019 decreased by 1.20%. In particular, the GHG emission from the energy sector was up by 4.33%, the IPPU sector was down by 30.63%, the agriculture sector was down by 16.85%, and the waste sector was down by 63.12%. Additionally, the carbon dioxide sequestration of the land use, land use change and forestry sector was down by 2.18%, as shown in Figure ES3.3.




1. Energy sector

The total greenhouse gas emission from the energy sector in 1990 was 110,525 kilotons of carbon dioxide equivalents and increased to 260,662 kilotons of carbon dioxide equivalents in 2019 with a growth of 135.84% and an annual average growth of 3.00%, as shown in Table ES3.2. During this period, the greenhouse gas emissions from the energy sector showed a downward trend in 2008 for the first time and declined again in 2009, followed by more reduction in 2012. Emissions produced by energy sector in 2019 increased by 4.33% compared to 2005(Base year). Compared with 2018, the greenhouse gas emissions in 2019 decreased by 3.14%. The total greenhouse gas emission from the energy sector in 2019 accounted for 90.80% of the total greenhouse

gas emission in Taiwan. In particular, 1.A.1 "energy industry" was responsible for 182,014 kilotons of carbon dioxide equivalents, accounting for 69.83% of the total greenhouse gas emission from the energy sector; 1.A.2 "manufacturing and construction industry" was responsible for 32,797 kilotons of carbon dioxide equivalents (accounting for 12.58%); 1.A.3 "transportation" was responsible for 36,238 kilotons of carbon dioxide equivalents (accounting for 13.90%); 1.A.4 "other sectors (including service industry, residential and agriculture, forestry, fishery and husbandry)" was responsible for 3.59%); 1.B.2 "oil and gas" was responsible for 258 kilotons of carbon dioxide equivalents (accounting for 0.10%), as shown in Figure ES3.4.




Figure ES3.3 Changes in Greenhouse Gas Emissions and Sequestrations by Sectors in Taiwan from 2005 to 2019.




Figure ES3.4 Percentage of Greenhouse Gas Emissions by Energy Sectors in Taiwan in (a)2005 and (b)2019.

2. Industrial Process and Product Use (IPPU) Sector

The greenhouse gas emission from the IPPU sector in 1990 was 14,629 kilotons of carbon dioxide equivalents and increased to 20,394 kilotons in 2019, a growth of 39.41% and

an annual average growth of 1.15%, as shown in Table ES3.3. Emissions produced by IPPU sector in 2019 decreased by 30.63% compared to 2005(Base year). Compared with 2018, the greenhouse gas emissions in 2019 decreased by 7.21%. The total greenhouse gas emission in 2019 accounted for 7.10% of the total greenhouse gas emission in Taiwan. In particular, 2.A "mining industry (non-metal process)" was responsible for 6,501 kilotons of carbon dioxide equivalents, accounting for 31.88% (the majority) of the greenhouse gases from the IPPU sector, followed by 2.C "metal process", which was responsible for 6,412 kilotons of carbon dioxide equivalents (accounting for 31.44%), 2.E "electronics industry", which was responsible for 3,885 kilotons of carbon dioxide equivalents (accounting for 3,885 kilotons)

19.05%), 2.8 "chemical industry", which was responsible for 2,623 kilotons of carbon dioxide equivalents (accounting for 12.86%), 2.F "alternatives to ozone-depleting substances", which was responsible for 846 kilotons of carbon dioxide equivalents (accounting for 4.15%), 2.G. "manufacturing and use of other products", which was responsible for 110 kilotons of carbon dioxide equivalents (accounting for 0.54%), and 2.H. "others", which was responsible for 17 kilotons of carbon dioxide equivalents (accounting for 0.08%), as shown in Figure ES3.5.

3. Agriculture Sector

In 2019, the greenhouse gas emissions from the agriculture sector totaled 3,301 kilotons of carbon dioxide equivalents, accounting for 1.15% of the total greenhouse gas emission in Taiwan, approximately down by 34.63% compared to 5,049 kilotons of carbon dioxide equivalents in 1990, with an average annual growth rate of -1.46%, as shown in Table ES3.4. Emissions produced by the agriculture sector in 2019 decreased by 16.85% compared to 2005(Base year). Compared to 2018, the greenhouse gas emissions from the agriculture sector in 2019 were down by 1.38%. In particular, greenhouse gas emissions from 3.D "agricultural soil" accounted for 35.88%, greenhouse gas emissions from

3.B "livestock waste treatment" accounted for 27.23%, greenhouse gas emissions from 3.C "rice culturing" accounted for 18.50%, greenhouse gas emissions from 3.A "livestock gastrointestinal fermentation" accounted for 17.41%, greenhouse gas emissions from 3.H "urea use" accounted for 0.89%, and greenhouse gas emissions from 3.F "field burning of agricultural residues" accounted for 0.10%, as shown in Figure ES3.6.

4. Land use, land use change and forestry (LULUCF) sector

The main greenhouse gas sequestrated by the land use, land use change and forestry (LULUCF) sector is carbon dioxide, while the change in the annual sequestration does not vary much with the exception of trends in minor fluctuations






Figure ES3.6 Percentage of Greenhouse Gas Emissions by Agriculture Sectors in Taiwan in 2005 (left) and 2019(right).

for the sequestration in the past. It is mainly because of the increased sequestration from the annual growth of forest resources while the sequestration reduced from the increased sequestration of forestation and the forest interference is less. The greenhouse gas emission from land use and forestry sector in Taiwan from 1990 to 2019 (mainly consisting of carbon dioxide sequestration by forestry resources) is shown in Table ES3.5. The carbon dioxide sequestration by forestry actor in 1990 was 23,386 kilotons of carbon dioxide equivalents. Compared to 2005(base year), the sequestration in 2019 were down by 2.18%. The sequestration in 2019 was 21,440 kilotons of carbon dioxide equivalents, down by 0.31% compared with 2018. The carbon dioxide sequestration between 1990 and 2019 decreased by 8.32% with an average annual growth rate of -0.30%.

5. Waste sector

In 1990, The greenhouse gas emissions by waste sector was 7,573 kilotons of carbon dioxide equivalents. The emissions from the waste sector in 2019 were 2,703 kilotons of carbon dioxide equivalents, approximately accounting for 0.94% of the total greenhouse gas emission in Taiwan (as shown in Table ES3.6), down by 64.30% compared with 1990, with an average annual growth of -3.49%. Emissions produced by the waste sector in 2019 decreased by 63.12% compared to 2005(Base year). Compared to 2018, the greenhouse gas emissions from the waste sector in 2019 were down by 1.83%. Among the waste sector's emissions in 2019, greenhouse gas emissions from 5.D "wastewater treatment and discharge" accounted for 65.81%, followed by greenhouse gas emissions from 5.A "solid waste disposal", accounting for 24.26%, greenhouse gas emissions from 5.C "waste incineration and opening burning", accounting for 8.21%, greenhouse gas emissions from 5.B "waste biological disposal", accounting for 1.73%, as shown in Figure ES3.7.




Figure ES3.7 Percentage of Greenhouse Gas Emissions by Waste Sectors in Taiwan in 2005 (left) and 2018(right).



ES.4 Other Information

According to the Durban Accord, all countries listed under Annex 1 shall submit the National Inventory Report, Biennial Report, and National Communications, while countries not listed under Annex 1 shall submit the Biennial Update Report and National Communications. These national reports all relate to the content of National Greenhouse Gas Inventory. Taiwan is currently taking the initiative in establishing a national system that is feasible to conform to Taiwan's customs, division of labor in sectors, and the hierarchical management of database. In addition to formulating regulations governing national greenhouse gas inventory review, Taiwan also established a review committee, a review on greenhouse gas inventory, and a sound management system to comply with procedures of Measurement Reporting, and Verification (MRV). Moreover, to comply with the UNFCCC, Taiwan shall apply the 2006 IPCC Guidelines for National Greenhouse Gas Inventories (hereinafter referred to as 2006 IPPC Guidelines) starting in 2015. Taiwan has started preparing a national greenhouse gas inventory with 2006 IPCC Guidelines-based statistical foundation and framework in addition to designing and establishing a registration platform for electronics national greenhouse gas inventory starting in 2013. At the same time, the relevant departments will test run this registration platform and submit the national greenhouse gas inventory statistics online. Taiwan has comprehensively adopted the 2006 IPCC Guidelines in step with the UNFCCC starting in 2015.
